

Specialized Labour Tax Credit

The Specialized Labour Tax Credit is intended to help kick-start new business growth by providing an incentive for workers with specialized expertise or skills to accept employment on Prince Edward Island — where that knowledge or skill is not yet available in the PEI labour market. The tax rebate applies to the personal income tax paid, to a maximum of 17%, on eligible income earned by the eligible individual. This tax credit is effective for one year from the start date of employment.

WHO MAY APPLY

This tax credit may be available to specialized workers who migrate to Prince Edward Island to fill a specific, identified position which the employer can demonstrate could not be filled from the existing PEI labour pool. The company must advertise the available position(s) through local print news media to be considered. The application is initiated by the company which will employ the worker. On approval, the certificate will be granted to approved individuals who are accepting pre-arranged employment with certified companies.

The company must be active in a strategic sector: aerospace; bio-science; export-focused manufacturing and processing; financial services; interactive, information and communications technology; or renewable energy.

A company will not be approved for an Innovation and Development Labour Rebate and a Specialized Labour Tax Credit on the same position.

PROCESS

Companies wishing to recruit specialized labour make application to the Department of Innovation and Advanced Learning through Innovation PEI. This tax credit is not automatically available and an application must be received prior to an offer of employment.

If the circumstance and the proposed employee are approved, an agreement is entered into by the company and Innovation PEI. A certificate is then issued to the employee. To claim the rebate, the employee submits the certificate and a copy of the Notice of Assessment and T4 for eligible employment to Innovation PEI.
