Provincial Tax Credit Application General Information

Purpose

For qualifying residents of Prince Edward Island, the Provincial Tax Credit program provides a tax credit on provincial property taxes based on the non-commercial real property taxable value assessment.

Who Is Eligible

All residents of Prince Edward Island who own non-commercial real property in Prince Edward Island are eligible for the Provincial Tax Credit program.

For purposes of the program, a resident of Prince Edward Island is defined as:

- 1) An individual who resides in Prince Edward Island for 183 consecutive days or more during each taxation year (January 1 and December 31).
- 2) A corporation where 50% or more of the voting shares are held by persons who are residents of Prince Edward Island.

For the purposes of the Provincial Tax Credit program the following non-commercial real property is deemed to be owned by a resident:

- Non-commercial real property which is jointly owned, where 50% or more of the owners are residents of Prince Edward Island.
- Non-commercial real property held in trust by a guardian or trustee for a resident of Prince Edward Island.
- 3) Non-commercial real property in which a resident of Prince Edward Island holds a registered life interest.

Section 5 of the Real Property Tax Act

Under Section 5 of the *Real Property Tax Act* and related *Real Property Tax Act* Regulations, a resident person or resident corporation in whose name non-commercial realty is assessed pursuant to the *Real Property Assessment Act*, except a person or corporation holding in trust non-commercial real property owned by a non-resident person or non-resident corporation, is eligible to receive the provincial tax credit at the rate of \$0.50 per \$100 of taxable value assessment.

How the Program Works

The provincial tax rate on all taxable real property in Prince Edward Island is \$1.50 per \$100 of taxable value assessment. Residents of Prince Edward Island who qualify for the provincial tax credit will receive a tax credit equal to \$0.50 per \$100 of non-commercial taxable value assessment.

How to Apply

Complete the attached Provincial Tax Credit Application Form and return it, with the required proof of residency documents, to the Department of Finance - Taxation and Property Records Division.

The Provincial Tax Credit Application form must be signed (Section E) by:

- (a) all owner(s) who have title to the property;
- (b) a guardian, or trustee; or
- (c) a person with a registered life interest.

How to Prove Residency

Please attach a copy of one of the following documents to provide proof of residency:

(1) Valid Prince Edward Island Drivers License

If you are unable to provide the required proof of residency documentation but you believe you may be eligible for the Provincial Tax Credit program based on the description in the **Who is Eligible** section above, please contact the Taxation and Property Records at (902) 368 4070 or by email at taxandland@gov.pe.ca.
