Pursuant to clause 10(a) of the Executive Council Act R.S.P.E.I. 1988, Cap. E-12 Council authorized the Minister of Transportation and Public Works to enter into an agreement with the Government of Canada, as represented by the Minister of Transport, to establish terms and conditions of funding for the administration, application and enforcement of National Safety Council standards to motor carriers in Prince Edward Island, such as more particularly described in the draft agreement.

HIGHWAY TRAFFIC ACT FEES REGULATIONS **AMENDMENT**

- 1. Table 4 of the Highway Traffic Act Fees Regulations (EC309/93) is amended in respect of the entry in column 1 relating to Abstract of driver record, by the deletion of the words "\$15" and the substitution of the words "\$20".
- 2. These regulations come into force on April 11, 2005.

L-5, Council amended the condition of non-development made pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately seventy (70) acres of land, being Provincial Property No. 879510 located in Lot 30, Queens County, Prince Edward Island and currently owned by Mark Butcher and Margaret Butcher, both of Crapaud, Prince Edward Island.

Council noted that this amendment will enable subdivision of a parcel of land of approximately five (5) acres, and determined that following subdivision, identification for non-development use shall continue to apply to the new parcel as well as to the remaining land.

This Order-in-Council comes into force on 12 April 2005.

PRINCE EDWARD ISLAND LANDS PROTECTION ACT LAND IDENTIFICATION REGULATIONS AMENDMENT

Pursuant to clause 17(1)(d) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council made the following regulations:

- 1. Section 4 of the *Prince Edward Island Lands Protection Act* Land Identification Regulations (EC606/95) is revoked and the following substituted:
- **4.** The land identification program does not apply where

Program does not apply

- (a) the land is within the boundaries of a municipality that has an apply official plan approved by the Minister under the *Planning Act* R.S.P.E.I. 1988, Cap. P-8; or
- (b) the land is not located within the boundaries of a municipality referred to in clause (a), and
 - (i) the land consists of a parcel of less than 5 acres or having a shore frontage of less than 165 feet, or
 - (ii) approval has been granted for the development of the entire parcel of land.
- 2. Section 8 of the regulations is amended by the addition of the following after subsection (2):
- (3) Notwithstanding subsection (1), any land identification agreement Exception that identifies any land in a municipality as referred to in clause 4(a) ceases to apply in respect of such land.
- 3. These regulations come into force on April 23, 2005.

EXPLANATORY NOTES

SECTION 1 deals with exclusions from the land identification program.

SECTION 2 provides that a land identification agreement in a municipality with an official plan ceases to apply in respect of land subject to an official plan.

SECTION 3 is the commencement of these regulations.

Under authority of subsection 85(2) of the *Youth Criminal Justice Act* S.C. 2002, c. 1, Council designated Unit B of the Prince Edward Island Youth Centre, 159 Greenwood Drive, Summerside, Prince Edward Island as a place of temporary detention and secure custody for the purposes of the Act, effective April 12, 2005.
