P.E.I. STUDENT FINANCIAL ASSISTANCE CORPORATION
AUTHORITY TO BORROW**

Pursuant to section 9 of the *Student Financial Assistance Act* R.S.P.E.I. 1988, Cap. S-8.2, Council authorized the P.E.I. Student Financial Assistance Corporation to borrow from the Minister of Finance and Municipal Affairs an amount not to exceed thirty million dollars (\$30,000,000.00) to administer the Prince Edward Island Student Loan Program.
