Under authority of subsection 35(1) of the *Judicature Act*, R.S.P.E.I. 1988, Cap. J-2.1, Council approved the Seventeenth Series of Amendments to the 1996 Consolidated Version of the Rules of Court to come into force effective October 1, 2013, said amendments having been made by the Rules Committee at meetings held in November 2012 and in February and May 2013.

Further, under authority of subsection 35(5) of the said Act, Council determined that publication of a Notice in the Royal Gazette shall be deemed to be publication of the approved Seventeenth Series of Amendments to the 1996 Consolidated Version of the Rules of Court and that no further publication relating to the said amendments shall be necessary.

Having under consideration Order-in-Council No. 652/55 and a Proclamation issued on December 29, 1955 pursuant to *The Village Services Act, 1954*; a resolution approved by the Community of Kinkora on March 27, 2013; and a recommendation from the Minister of Finance, Energy and Municipal Affairs; Council hereby accepts the request of the Community of Kinkora to increase the composition of its council, effective the date of the next municipal election, to a total of seven members, being a chairperson and six councillors, in accordance with clause 15(1)(b) of the *Municipalities Act*, R.S.P.E.I. 1988, Cap. M-13.
