Pursuant to subsection 9(2) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council amended the condition of non-development use made pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately eighty-nine (89) acres of land, being Provincial Property No. 848994 located at Marshfield, Lot 34, Queens County, Prince Edward Island and currently owned by Beau View Farm Ltd. of Breadalbane, Prince Edward Island.

Council noted that this amendment will permit (i) consolidation with adjoining Provincial Property No. 140384, and (ii) subsequent subdivision of one lot of approximately two (2) acres for residential use within the Charlottetown Region Special Planning Area, subject to the proposed subdivision meeting all requirements of the *Planning Act* R.S.P.E.I. 1988, Cap. P-8 and Regulations.

Further, Council determined that following consolidation/subdivision, identification for non-development use shall continue to apply to the remaining eighty-seven (87) acre portion of the parent parcel and to the new lot of approximately two (2) acres.
