

**EC2017-102****EDUCATION ACT  
STUDENT REGULATIONS  
AMENDMENT**

Pursuant to subsection 26(2) and section 107 of the *Education Act* R.S.P.E.I. 1988, Cap. E-.02, Council made the following regulations:

**1. Clause 2(2)(f) of the *Education Act* Student Regulations (EC531/16) is amended by the addition of the words “, if applicable” after the words “health information”.**

**2. Clauses 3(2)(f) and 4(2)(f) of the regulations are amended by the addition of the words “, if applicable” after the words “health information”.**

**3. Subsection 11(1) of the regulations is amended by the deletion of the word “five” and the substitution of the word “ten”.**

**4. Subsection 13(3) of the regulations is amended by the addition of the word “business” after the word “ten”.**

**5. Subsection 15(2) of the regulations is amended by the addition of the word “business” after the word “ten”.**

**6. These regulations come into force on March 11, 2017.**

**EXPLANATORY NOTES**

**SECTION 1** amends clause 2(2)(f) of the *Education Act* Student Regulations (EC531/16) to clarify that the information an applicant must provide under that clause is required only if applicable in the circumstances of the enrolment of the school-aged child under that section.

**SECTION 2** amends clauses 3(2)(f) and 4(2)(f) of the regulations to clarify that the information an applicant must provide under those clauses is required only if applicable in the circumstances of the enrolment of a school-aged child under either of those sections.

**SECTION 3** amends subsection 11(1) of the regulations to extend the notice period for an appeal under section 55 of the Act from five business days to ten business days.

**SECTION 4** amends subsection 13(3) of the regulations to change the length of the period within which the hearing committee must give notice of a hearing to a parent and the education authority from ten days to ten business days.

**SECTION 5** amends subsection 15(2) of the regulations to change the length of the period after completing a hearing within which the hearing committee must produce and give notice of its decision to a parent and the education authority from ten days to ten business days.

**SECTION 6** provides for the commencement of the regulations.

**1. Section 9 of the *Education Act* School Calendar Regulations (EC530/16) is revoked.**

**EXPLANATORY NOTES**

**SECTION 1** revokes a section that the Department and the education authorities no longer need as this information is not currently required for administrative purposes. Also, this information can be obtained upon request without relying on a regulatory provision.
