AMENDMENT**

Pursuant to section 72 of the *Public Health Act* R.S.P.E.I. 1988, Cap. P-30.1, Council made the following regulations:

1. Clause 1.1(1)(d) of the *Public Health Act* Notifiable Diseases and Conditions and Communicable Diseases Regulations (EC560/13) is amended

(a) by the revocation of subclause (i) and the substitution of the following:

- (i) carbapenemase-producing *Enterobacteriaceae*,
- (i.1) *Clostridium difficile*,

(b) by the addition of the following after subclause (iii):

- (iii.1) extensively drug-resistant *Enterobacteriaceae*,

2. These regulations come into force on July 15, 2017.

EXPLANATORY NOTES

SECTION 1 prescribes carbapenemase-producing *Enterobacteriaceae* and extensively drug-resistant *Enterobacteriaceae* as notifiable diseases or conditions.

SECTION 2 provides for the commencement of these regulations.

EXPLANATORY NOTES

SECTION 1 amends the Summary Offence Ticket Schedule for the *Highway Traffic Act* to add a new offence, where the operator or passenger on a motorcycle fails to remove the crash helmet or any face covering he or she is wearing, on request, after coming to a safe stop when signalled or requested to stop by a peace officer.

SECTION 2 provides for the commencement of these regulations.
