ESTIMATES OF CAPITAL EXPENDITURE
FISCAL YEAR 2018-2019

This Council in Committee, having under consideration the Estimates of Capital Expenditure required to carry on the Public Service of the Province for the Fiscal Year ending March 31, 2019, and amounting in all to the sum of One Hundred and Thirty-Three Million, Eight Hundred and Sixty-Five Thousand, Two Hundred Dollars (\$133,865,200), together with a sum sufficient for similar Capital expenditure, to carry on the Public Service of the Province from the expiration of the Fiscal Year ending March 31, 2019 up to and until the final passage of the Capital Estimates for the Fiscal Year ending March 31, 2020, it was and is hereby recommended that the Capital Estimates be approved by Her Honour, the Lieutenant Governor of the Province of Prince Edward Island, and be presented to the Legislative Assembly during the present session thereof.
