This Council in Committee, having under consideration the Estimates of Current Expenditure required to carry on the Public Service of the Province for the Fiscal Year ending March 31, 2020, and amounting in all to the sum of Two Billion, and Sixty-Seven Million, One Hundred and Forty-Five Thousand Dollars (\$2,067,145,000), together with a sum sufficient for similar expenditure, to carry on the Public Service of the Province from the expiration of the Fiscal Year ending March 31, 2020 up to and until the final passage of the Current Estimates for the Fiscal Year ending March 31, 2021, it was and is hereby recommended that the Current Estimates be approved by Her Honour, the Lieutenant Governor of the Province of Prince Edward Island, and be presented to the Legislative Assembly during the present session thereof.

EC2019-464**VICTIMS OF CRIME ACT****REGULATIONS**

Pursuant to section 37 of the *Victims of Crime Act* R.S.P.E.I. 1988, Cap. V-3.1, Council made the following regulations:

1. For the purposes of subsection 9(2) of the Act, the amount of surcharge imposed under subsection 9(1) in respect of a conviction for an offence under an enactment is \$25. Amount of surcharge
2. Money received by the appropriate court official in respect of a conviction for an offence under an enactment shall be applied in the following order: Priority
 - (a) in payment of the surcharge;
 - (b) in payment of the fine.

3. For the purposes of subsection 15(3) of the Act, the prescribed amount of compensation in respect of small claims is \$1,000. Small claims
4. For the purposes of clause 16(1)(a) of the Act, the sections of the *Criminal Code* (Canada), set out in column 1 of the Schedule to these regulations relating to the offences described in column 2, are the prescribed sections. Entitlement to Compensation
5. For the purposes of subsection 25(1) of the Act, the maximum amount of compensation that may be awarded to all applicants Maximum compensation
- (a) in respect of the injury or death of one victim is \$15,000; and
- (b) in respect of one occurrence is \$30,000.
6. The *Victims of Crime Act* Regulations (566/89) are revoked. Revocation
7. These regulations come into force on July 6, 2019. Commencement

EXPLANATORY NOTES

SECTION 1 provides for the amount of surcharge in respect of a conviction for an offence under an enactment.

SECTION 2 provides for the order of payment of money received by a court official in respect of a conviction for an offence under an enactment.

SECTION 3 outlines the amount of small claims compensation.

SECTION 4 outlines the relevant offence provisions of the *Criminal Code* contained in the Schedule, the commission of which may result in injury or death of a person.

SECTION 5 outlines the maximum amount of compensation that may be awarded to applicants in respect of the occurrence of injury or death of a victim.

SECTION 6 revokes the *Victims of Crime Act Regulations (566/89)*.

SECTION 7 provides for the commencement of these regulations.
