**PUBLIC HEALTH ACT

NOTIFIABLE DISEASES AND CONDITIONS AND
COMMUNICABLE DISEASES REGULATIONS
AMENDMENT**

Pursuant to section 72 of the *Public Health Act* R.S.P.E.I. 1988, Cap. P-30.1, Council made the following regulations:

1. **Subsection 1.1(1) of the *Public Health Act* Notifiable Diseases and Conditions and Communicable Diseases Regulations (EC560/13) is amended**
 - (a) **by the revocation of clause (e) and the substitution of the following:**
 - (e) diseases transmitted by respiratory routes, including but not limited to:
 - (i) COVID-19,
 - (ii) hantavirus,
 - (iii) invasive group A streptococcal disease,
 - (iv) invasive meningococcal disease,
 - (v) invasive pneumococcal disease,
 - (vi) influenza,
 - (vii) legionellosis,
 - (viii) leprosy,
 - (ix) severe acute respiratory illness,

- (x) severe acute respiratory syndrome,
- (xi) tuberculosis;

(b) in clause (m), by the addition of the following after subclause (v):

- (v.1) monkeypox,

2. Subsection 9.1(5) of the regulations is amended

(a) in subclause (a)(iv), by the deletion of the words “an influenza-like illness” and the substitution of the words “a communicable disease”; and

(b) in clause (b), by the addition of the following after subclause (iv):

- (iv.1) monkeypox,

3. These regulations come into force on July 9, 2022.

EXPLANATORY NOTES

SECTION 1 amends subsection 1.1(1) of the Notifiable Diseases and Conditions and Communicable Diseases Regulations (EC560/13) under the *Public Health Act* R.S.P.E.I. 1988, Cap. P-30.1, to add COVID-19 in alphabetical order to the list of diseases transmitted by respiratory routes that are listed in clause (e), and to add monkeypox to the list of vectorborne or other zoonotic diseases in clause (m).

SECTION 2 amends subclause 9.1(5)(a)(iv) of the regulations to delete the words “an influenza-like illness” and substitute the words “a communicable disease”, and clause 9.1(5)(b), to add “monkeypox” as a new clause (iv.1).

SECTION 3 provides for the commencement of these regulations.
