**REGULATED HEALTH PROFESSIONS ACT**  
**PHARMACIST AND PHARMACY TECHNICIAN REGULATIONS**  
**AMENDMENT**

Pursuant to sections 2 and 96 of the *Regulated Health Professions Act* R.S.P.E.I. 1988, Cap. R-10.1, Council made the following regulations:

**1. (1) Subsection 23(1) of the *Regulated Health Professions Act* Pharmacist and Pharmacy Technician Regulations (EC445/19) is revoked and the following substituted:**

**23. Performing blood tests**

- (1) Subject to subsection (2), a pharmacist may perform a procedure on tissue below the dermis to collect blood for one of the following tests to monitor and manage drug therapy:
- (a) international normalized ratio (INR);
  - (b) glycated haemoglobin (haemoglobin A1c or HbA1c); or
  - (c) blood glucose.

**(2) Section 23 of the regulations is amended by the addition of the following after subsection (1):**

**Interpreting tests**

- (1.1) Subject to subsection (2), a pharmacist may interpret screening and diagnostic tests that do not use prescribed forms of energy to monitor and manage drug therapy.

**(3) Subsection 23(2) of the regulations is revoked and the following substituted:**

**Pre-conditions**

- (2) A pharmacist shall not perform a blood test under subsection (1) or interpret a test under subsection (1.1) unless
- (a) the pharmacist believes that it is in the best interests of the patient in accordance with
    - (i) standards of practice,
    - (ii) the code of ethics, and
    - (iii) any applicable practice directives issued by the College; and
  - (b) the pharmacist
    - (i) provides the patient or representative with sufficient information to make an informed and voluntary decision regarding the test, and
    - (ii) obtains the informed consent of the patient or representative.

**2. These regulations come into force on November 12, 2022.**

**EXPLANATORY NOTES**

**SECTION 1** revokes and replaces subsections 23(1) and (2) of the regulations and adds a new subsection 23(1.1) to the regulations to authorize a pharmacist to perform two reserved activities, subject to specified pre-conditions.

**SECTION 2** provides for the commencement of these regulations.
