Pursuant to sections 2 and 96 of the *Regulated Health Professions Act* R.S.P.E.I. 1988, Cap. R-10.1, Council made the following regulations:

1. **Section 18 of the *Regulated Health Professions Act* Licensed Practical Nurses Regulations (EC150/18) is amended by the addition of the following after subsection (2):**

Administering a vaccine

 - (3) Notwithstanding subsection (2), a licensed practical nurse is authorized to administer by any means a vaccine prescribed by a person authorized to practise as a pharmacist under the laws of this province.

Pursuant to sections 2 and 96 of the *Regulated Health Professions Act* R.S.P.E.I. 1988, Cap. R-10.1, Council made the following regulations:

1. **Section 13 of the *Regulated Health Professions Act Registered Nurses Regulations* (EC551/23) is amended by the addition of the following after subsection (2):**

Administering a vaccine
 - (3) Notwithstanding subsection (2), a registered nurse is authorized to administer by any means a vaccine prescribed by a person authorized to practise as a pharmacist under the laws of this province.
