BUILDING CODES ACT

BUILDING CODES REGULATIONS AMENDMENT

Pursuant to section 32 of the *Building Codes Act* R.S.P.E.I. 1988, Cap. B-5.1, Council made the following regulations:

- 1. (1) Subsection 2(1) of the *Building Codes Act* Building Codes Regulations (EC177/20) is amended by the deletion of the words ", 2015, is hereby adopted, including all revisions, amendments and corrections made by the Canadian Commission on Building and Fire Codes," and the substitution of the words "2020, is hereby adopted, including all revisions, amendments and corrections published by the".
- (2) Subsection 2(2) of the regulation is amended by the deletion of the words ", 2017, is hereby adopted, including all revisions, amendments and corrections made by the Canadian Commission on Building and Fire Codes," and the substitution of the words "2020, is hereby adopted, including all revisions, amendments and corrections published by the".
- 2. Clause 4(f) of the regulations is revoked and the following substituted:
 - (f) a farm building that is within the scope of the National Farm Building Code of Canada, 1995, published by the National Research Council of Canada or that is within the scope of the National Building Code of Canada 2020;
- 3. These regulations come into force on March 31, 2024.

EXPLANATORY NOTES

SECTION 1 amends section 2 of the *Building Codes Act* Building Codes Regulations (EC177/20) to adopt the National Building Code of Canada 2020 and the National Energy Code of Canada for Buildings 2020.

SECTION 2 revokes clause 4(f) of the regulations and substitutes a new clause 4(f) to correct the terminology and add a reference to the National Building Code of Canada 2020.

SECTION 3 provides for the commencement of these regulations.

ENVIRONMENTAL PROTECTION ACT

A CODE FOR PLUMBING SERVICES REGULATIONS AMENDMENT

Pursuant to clause 25(1)(f) of the Environmental Protection Act R.S.P.E.I. 1988, Cap. E-9, Council made the following regulations:

- Subsection 1(1) of the Environmental Protection Act A Code for Plumbing 1. Services Regulations (EC666/86) is amended by the deletion of the words "Code of Canada 2015 Edition" and the substitution of the words "Code of Canada 2020".
- 2. Clause 2(1)(a) of the regulations is amended by the deletion of the words "Code of Canada 2015" and the substitution of the words "Code of Canada 2020".
- 3. Section 3 of the regulations is amended by the deletion of the words "The National Plumbing Code of Canada 2015 Edition" and the substitution of the words "The National Plumbing Code of Canada 2020".
- 4. Subsections 4(2) and (3) of the regulations are revoked.
- 5. These regulations come into force on March 31, 2024.

EXPLANATORY NOTES

SECTION 1 amends subsection 1(1) of the Environmental Protection Act A Code for Plumbing Services Regulations (EC666/86) to adopt the National Plumbing Code of Canada 2020.

SECTION 2 amends the definition of "Code" in clause 2(1)(a) of the regulations to refer to the National Plumbing Code of Canada 2020.

SECTION 3 amends section 3 of the regulations to refer to the National Plumbing Code of Canada 2020.

SECTION 4 revokes subsections 4(2) and (3) of the regulations. These subsections modified the application of the National Plumbing Code of Canada 2015 and are no longer applicable.

SECTION 5 provides for the commencement of these regulations.
