The Department of Environment, Energy and Climate Action (herein referred to as the Department), Provincial Forest Section, Eastern District invites tender submissions for *Reforestation 2024* for the Eastern Forest District for tree planting (including microsite preparation) for the spring of 2024 as detailed in the following Tender Form. The contract is to be completed as per the attached specifications found in Schedule A.

The successful bidder shall be asked to sign a contract for the term of June 2nd, until July 30th, 2024 (*or an extension date approved by the Department).

Partial completed quotes will be considered invalid. In the event of identical quotes, the parties involved shall be requested to resubmit a price equal to or lower than their first quote. The contractor must provide a decision to accept or reject the contract within 72 hours of notification.

Note: Several properties have more than one planting site (component) identified. However, only the “Total Price (for planting & microsite) Per Tree” will be considered in determining the placement order of the tenders received. Tender price is not to include H.S.T. **Lowest or any tender not necessarily accepted.**

***IMPORTANT:** *No penalties will be assessed for stocking where it is deemed that a suitable microsite for planting was not available due to excessive harvest debris. The intention is to meet general prescribed spacing requirements. (Total seedling numbers per site prescribed on the seedling allocation sheet are estimates of what should be required based on the prescribed density.)*

¹IMPORTANT: *Duff kicked microsites are bid per site but may not be necessary for all sites, to be paid only where the duff layer is thick or undisturbed. It is the responsibility of the contractor to record the number of microsites established post planting for payment*
